Legal Duties

As a school we welcome our duties under the Equality Act 2010. The general duties are to:

- Prepare and publish equality objectives

EQUALITY OBJECTIVES

All groups with protected characteristics are included within our objectives: ***Age, Disability, Gender Reassignment, Marriage and Civil Partnership, Pregnancy and Maternity, Race, Religion or Belief, Sex, Gender and Sexual Orientation.***

Elimination of discrimination, advancement of equality of opportunity and fostering of good relations underpin the objectives in meeting the general duties in our Equalities Plan. We:

- Provide a broad, balanced, ambitious and culturally rich curriculum.
- Strive to ensure that all protected characteristics are authentically represented within our curriculum and environment.
- Provide an adapted curriculum, tailored to include reasonable adjustments, where appropriate, to meet the needs of all children.
- Monitor and analyse the attainment and progress of all children, including those with SEND and any other group with a protected characteristic.
- Provide an environment that is safe and accessible to all pupils and one which fosters understanding and acceptance of any difference.
- Provide opportunities for children to increase their awareness and understanding of different faith groups.
- Provide on-going opportunities for training as part of staff appraisals to enable and advance equality of opportunity within the staff team.
- Continue to provide opportunities to build community cohesion with friends and neighbours of the school through invitation to events or by taking part in community events, e.g. carol singing.
